 *Health Coverage questions By next January health care cost will go up (it always does regardless of negotiations). The current 85/15 split is consistent and right at the midpoint with what other

districts in the county pay (a few are 90/10 and 80/20). We may be asked to consider a high-deductible plan, in addition to other plans we currently have.

 - a. **Motion** to approve Gina Lord as Chair of the Harry Karpinski Scholarship Committee - **approved**
 - b. Motion to Approve Mike Silivestro as Chair of the Election Committee – approved
 *Mike will be assembling a committee of 5 members. It took some time to locate an Election Chairperson, so thank you Mike for stepping up!
 - **c.** RA (Representative Assembly) this week in NYC. Andy Jordan and Joe Alati attending. The vote for "Jordan for ED 6" will occur at the RA.

*The RA is like the DNC or RNC for NYSUT. This is an annual meeting, where about 1,800 delegates participate to vote of NYSUT officers and directors, discuss and vote on amendments and resolutions, and get to network, discuss and debate with other union members. There are 2 caucuses: The bigger and long standing Unity Caucus, and the newer Stronger Together Caucus. The RA sets the stage for NYSUT going forward this next year. *At this year's RA, there is not a lot of controversial ballots, but an important vote will be on a constitutional amendment the entails voting locations for the annual RA. The problem is with our smallest locals that represent less than 50 members, and find it difficult to go to NYC due to cost. NYUST has begun scheduling RAs where it is cheaper to attend (Buffalo, Rochester, Saratoga). The constitutional amendment to vote on would cancel the need for the RA, as votes could take place in regional offices. We see this as an important issue, to engage our smaller locals, but are concerned that the RA provides opportunities for members to sit and talk with colleagues, to have an annual celebration, and come together to debate with NYSUT members across the state. *All NYSUT officer seats are being contested but one *Andy running unopposed for ED 6

d. Harry Karpinski Scholarship: An email with the application will be sent out before April break. Parents, grandparents, step-parents of

graduating seniors can apply for this scholarship (includes retirees if they are active subs, need to be working at BOCES currently).

e. Three Seasons Issue-Working without pay
*Members have been working to deliver lunch during their lunch hours for 35 years unpaid. Meeting with HR coming up to discuss these members getting paid for working during their lunch hour. This involves four individuals. Lunch is guaranteed by labor law and state regulations, must be a 30-minute period between 11am – 2pm, and this time has to be unencumbered.

*If I choose to work through lunch, my choice, district cannot demand it
